What is the RISSLeads Investigative Website?



The RISSLeads Investigative Website (RISSLeads) is dedicated to searching for and sharing investigative information. Authorized users are able to upload documents, photos and videos, search posted information, collaborate with other officers on cases, and generate leads. RISSLeads enables authorized law enforcement officers to post information regarding cases or other law enforcement issues. Users are able to view and respond to posts, ultimately working together by exchanging information on similar or related cases and generating investigative leads.

RISSLeads aims to aid law enforcement in advancing its investigations and providing a secure place to collaborate and learn from fellow officers.

What are the features of RISSLeads?

The RISSLeads landing page has information designed to introduce users to the website's purpose and guide them through its functioning. From the landing page, users can navigate to a secure collaborative website with informational and instructive RISSLeads tools, including help videos and text. RISSLeads has unique features designed specifically for its users' needs including:

- » Creating posts and uploading files.
- » Searching submitted posts and uploaded files.
- » Filtering posts based on specific topics or author.
- » Viewing specific content types.
- » Viewing and posting events and training to a shared calendar.

About RISS

RISS is a proven, trusted, and evidence-based program that supports the needs of thousands of local, state, federal, and tribal criminal justice and public safety professionals while helping advance the nation's criminal justice strategy. RISS is composed of six regional centers and the RISS Technology Support Center. RISS focuses on three priorities: investigative case support; secure information and intelligence sharing; and officer safety, deconfliction, and law enforcement wellness. RISS offers full-service delivery, from the beginning of an investigation to the ultimate prosecution and conviction of criminals. An officer can simultaneously query multiple intelligence databases, retrieve information from investigative systems, obtain assistance from intelligence research staff, borrow equipment, receive training, and use analytical resources to help prosecute criminals. RISS is congressionally funded and administered by the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance (BJA), through grant awards. BJA provides funding oversight and program management for the RISS Program.

Why should I use RISSLeads?

Connecting law enforcement officers across jurisdictional boundaries is crucial in detecting and apprehending today's mobile, wide-ranging, and sophisticated criminals. RISSLeads is an example of how geographically disparate law enforcement professionals can convene electronically to discuss cases and share investigative techniques.

RISSLeads is known for its powerful capability to enable officers to share investigative techniques and case information with other officers. With the newly designed and architected RISSLeads Investigative Website, law enforcement users can leverage these technologies to enhance and further their cross-jurisdictional investigative efforts.
